- 4. All contractors, irrespective of their enlistment or non enlistment with MES will certify in writing that they are registered with Pakistan Engineering Council (PEC), and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.
- 5. Contractors borne on approved List of MES in category 'A', 'B', 'C' & 'D' having experience of this type of work may only apply.
- 6. Contractors who desire may be present at the time of opening of tenders
- 7. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
