## **REQUEST FOR PROPOSALS**

### **CONSTRUCTION OF HYDERABAD – SUKKUR 6-LANE MOTORWAY UNDER PUBLIC PRIVATE PARTNERSHIP ON BUILD-OPERATE-TRANSFER BASIS**

1. National Highway Authority (“NHA”), Government of Pakistan is undertaking Construction of Peshawar-Karachi Motorway (“PKM”), a high speed, controlled access, 6-lane motorway system. The motorway forms part of trade corridor linking ports of Karachi and Gawadar with China, Afghanistan and Central Asian States. The general alignment runs parallel to the National Highway N-5, which carries approximately 65% traffic of Pakistan. All the segments of PKM have either been completed or awarded for construction except the Hyderabad – Sukkur motorway link of PKM Section.
2. Now NHA intends to undertake construction of Hyderabad – Sukkur Motorway approximately 306 Kilometer, 6-Lane Access Controlled Facility (“Project”) on Built-Operate-Transfer (“BOT”) basis. To improve the viability of project the GoP/NHA is also prepared to provide Viability Gap Fund (“VGF”) details shall be defined in the Request for Proposal (“RFP”).
3. NHA is soliciting proposals from well reputed national as well as international private entrepreneurs, joint ventures and consortia to undertake the project on BOT arrangement, wherein private party shall be responsible to finance, design, develop, construct, insure, operate, manage, maintain and transfer of the Project, at the end of concession period, to NHA.
4. The interested parties may obtain the Request for Proposal (“RFP”) documents, for the Project, from the office of undersigned during office hours against a (non-refundable) fee of Rs. 10,000/- (Pak Rupees ten thousand only), which is to be paid in the form of Bank Draft of Pay Order in favour of “National Highway Authority”. The RFP can also be downloaded from NHA Website ([www.nha.gov.pk](http://www.nha.gov.pk)) free of cost. The RFP shall be available from **September 24, 2021**.
5. The Pre-Bid Conference shall be held in NHA Auditorium at 1130 Hours on **October 20, 2021**. The last date for submission of Bids is November 18, 2021 till 1530 hours. The Bids will be opened on the same day at 1600 hours.
6. The NHA reserves the right to reject any or all Proposal(s).
