

The tender documents must reach at the office of the Directorate of Industries, Labour & Commerce GB on or before the dates and time mentioned above. Tender documents will be opened on same day as schedule given above in presence of Contractor or authorized representatives.

GENERAL TERMS & CONDITIONS:

1. Earnest money as mentioned above must be attached with the tender documents in form of demand draft/ pay order in the name of DDO, Directorate of Industries, and Labour & Commerce GB from any scheduled bank.
2. Tender with incomplete supporting documents shall not be accepted and furnishing incorrect information shall be liable to legal action. All bids/quoted rates shall be submitted in typed shape.
3. An affidavit on stamp paper of Rs. 100/ must be accompanied with the tender documents to the effect that the bidder has never been blacklisted by any Government/Semi-Government Organization/PPRA
4. The firm/contractor winning the bid shall be bound for repair & maintenance of vehicles of the Directorate of Industries, Labour and Commerce GB till 30 June, 2024.
5. The tender shall be considered lot wise and firm shall be bound to supply/provide goods/services at rates quoted in tender during the financial year 2023-2024
6. Firms quoting inappropriate rates above and below 15% of market rates shall not be considered.
7. The contractor must have his own shop/workshop at Gilgit and Islamabad to participate in the tender. Firm/ Contractor must have minimum three (03) years' experience in the relevant field can only participate in tender and supply orders/experience certificate/proof of experience must be attached with tender documents
8. Firms having their own shop/workshop/partnership/mutual working agreement shall have to provide proof of their own workshop/shop at Gilgit and Islamabad or shall have to provide N/partnership/mutual working agreement on stamp paper of Rs. 100 duly signed by both parties. No photocopy shall be accepted. In case of mutual work agreement proof ownership of shop/workshop of 2 parties shall be mandatory.
9. Bank statement of last three years would be required with closing balance of at least Rs. 1.00 million.
10. Tender documents containing detail of evaluation criteria, items, work and specifications may be obtained from the office of the undersigned during office hours before date and time of closing mentioned above. The procedure of single stage two envelopes shall be followed.
11. The department reserves right to accept or reject the tender according to Rule-33 of PPRA rule 2004.
12. Other than these items, if maintenance will be required during the current financial year then the quotation based work will be undertaken.
