**Background:**

The Pakistan Institute of Education (PIE) has deployed an Item Banking Software customized by the Federal Board of Intermediate and Secondary Education. The software serves as a critical component in the educational assessment process. PIE is seeking the services of a qualified consultant to enhance and improve the existing system, focusing on functionality and operationalization.

2. PIE seeks the services of a national consultant to provide technical support to NAW - PIE in the development, enhancement and deployment of item Banking software in NAW-PIE.

**Objectives:**

The primary objectives of engaging the consultant are as follows:

- Assess the current functionality of the Item Banking Software.
- Identify areas of improvement in terms of efficiency and effectiveness.
- Propose and implement enhancements to the software to align with PIE's specific needs.
- Ensure seamless operationalization of the improved system within PIE's existing infrastructure.

**Scope of Work:**

The consultant's responsibilities will include, but are not limited to:

- Conduct a comprehensive assessment of the current database structure.
- Identify and document any inefficiencies or limitations in the existing database.
- Propose improvements to optimize the database structure for better performance.
- Collaborating with PIE stakeholders to understand specific requirements and challenges.
- Implementing the approved enhancements in consultation with PIE's team.

- f) Testing the modified system to ensure compatibility and reliability.
- g) Implement robust security measures to safeguard sensitive educational data while ensuring compliance with relevant data protection regulations and standards
- h) Design the database architecture with scalability in mind to accommodate future growth. Implement techniques to handle an increasing volume of assessment data efficiently.
- i) Optimize database queries and indexing to enhance overall system performance and conduct performance testing to identify and address any bottlenecks or slowdowns.
- j) Ensure seamless integration of the enhanced Item Banking Software with PIE's existing IT infrastructure. Collaborate with PIE's IT team to address any compatibility issues.
- k) Implement role-based access control to restrict user access based on job responsibilities. Define and enforce user permissions to maintain data integrity and confidentiality.
- l) Collaborate with PIE staff to perform user acceptance testing (UAT) to validate the system's functionality.

In the event of any dispute arising between the bidder and the procuring agency regarding this bid or any other matter ancillary thereto whatsoever, the same shall be referred to the sole arbitrator i.e. Purchase Committee of NAW-PIE, MOFEPT. The Arbitrator shall give its award within two months from the date on which it enters upon the reference. The provisions of the Arbitration Act, 1940 shall apply to the arbitration proceeding. Reference to arbitration shall be a condition precedent for any other action at law. A specimen of the Affidavit regarding arbitration is enclosed.

9. **PENALTY:**

For failure to comply with agreed delivery schedule, the liquidated damages will be levied as under:




