However, each bid must cover the complete lot. bids for partial lots will not be accepted. Manual bids, shall not be accepted.
- Interested vendors are requested to submit their rates/tenders, which should be valid till close of Financial Year, 2024-25 i.e. 30.6.2025.
 - Income tax and other government taxes will be deducted at source as per rules.

 - GST and vendor number should be clearly written on the tender documents. The tenders without GST and Vendor number will not be entertained.

 - Original Bid Security instrument MUST be submitted to the under signed in favor of Assistant Manager (Admn), Invest Pakistan before closing hours of the bids submission time otherwise respective bid will not be opened and
