1. This Invitation to Tender/Bid (here in after referred to as IT), follows the procurement **Static Line Personnel Parachutes (50 x Main & 50 x Res Parachutes)** and **miscellaneous items** with following time lines:-

- a. Date and time of closing of this IT is **09 May 2025 at 1030 hours**.
- b. Date and time of opening of bids/ IT documents offered in response to this IT is **09 May 2025 at 1100 hours** in CMT&SD Golra Road Rawalpindi with representatives of bidders in attendance.

2. Sealed Bids are invited (in line with Single Stage, Two Envelope Process as specified in PPRA-Regulations) from Manufacturers, Agents of manufacturers, authorized distributors and suppliers, which are registered with Income Tax & Sales Tax Departments, on Active Taxpayer List (ATL) of Federal Board of Revenue (FBR) and Registered with Directorate General Defense Purchase (DGDP) / Directorate General Procurement-Army (DGP-A) / Any Ordnance Depots of Pakistan Army, CAF and Pakistan Engineering Council (PEC) for supply of items.

4. **Vendor Profile / Qualification Documents** as per details mentioned at **Annexure C**, must be submitted in separate envelope, clearly marked on the outside in bold letters as **"VENDOR'S PROFILE / QUALIFICATION DOCUMENTS"**.
5. Bids are to be submitted in two separate sealed envelopes, clearly marked on the outside in bold letters as **"TECHNICAL PROPOSAL"** and **"FINANCIAL PROPOSAL"**.
6. Failure to submit complete documents / details as asked **OR** failure to submit Technical Proposal, Financial Proposal and Vendor Profile / Qualification Documents in separate sealed envelopes is liable to cause outright rejection of bid.
7. **Bid Security equal to 5% of estimated bid value** is to be deposited, failing which bids are liable to be rejected.
8. Bid will be finalized in accordance with the rule specified in **PPRA Rule 30**.
9. Procurement is planned within **Current Financial Year (CFY)** in full or in part. Quantities can be amended/ decreased at the time of placing the order.
10. Along with tender, each firm will deposit Tender Fee (in the shape of CDR, Pay Order or Cross Cheque). Same will be prepared in the name of Comdt CMT&SD Golra.
11. Purchaser does not pledge to accept the lowest rates. He reserves the right to accept the whole or any part of the offer or completely reject the tender without explaining reason.
12. **Due to operational necessity and requirement of item, "Time is Essence" of this contract.**
13. All bidders are bound by Official Secret Act to ensure confidentiality of bids and purchases of stores and not share information / details of bid/ contract/ quantities/ delivery locations with anyone not party to the bid / purchase.
14. **Lab test report for Parachutes is mandatory from concerned inspection agencies / IAS&C Kci.**
