1. The Firm/Bidder shall submit Tender on the following terms and condition with all required documents, attached with bid, as per details given below:
 - (i) The Firm/Bidder should quote bid/rate on company's letter head along with detailed specifications for the unit price including all taxes / transportation charges(if any) to NAB Rawalpindi entirely in PAK Rupees against each item. The rates should be mentioned in both words and figures. Rates with cutting or overwriting will be considered as nonresponsive.
 - (ii) Following documents must be attached with bids:
 - i. Copy of Income Tax certificate
 - ii. Sales Tax certificate
 - iii. AGPR vendor number
 - iv. Refundable 3% earnest money of quoted value call deposit / bank draft in the name of NAB Rawalpindi

5. The Firm/Bidder shall also be responsible to install and demonstrate the required equipment at the site specified by the authority at bidders own cost (if required).
6. The Firm/Bidder shall be bound to provide catalogues with photos, samples of small instruments or any other information desired by the Technical / Inspection Committee or Purchase Committee.
