ELIGIBILITY

2. This Invitation for Bids is open to all Bidders who meet out the following requirements/criteria.
 - a. The Bidder/JV must completed at least two (02) No. contracts that have been successfully completed alongwith completion certificate within the last Eight (08) years similar to above works i.e pilling works etc, duly attested by sitting officer (mentioning its name and contact No.) of the work order, completion certificate issuing office.
 - b. The Bidders who will apply for issuance of tender as JV will provide the joint JV NTN, SRB & CDR.
 - c. Identity Card of Contractor/Managing Partner/Director of the firm or his authorized person.
 - d. Bidding documents will be issued only to the Owner or his authorized person having authority letter on Rs.100/- judicial stamp paper for receiving tender documents/participants in tenders.
 - e. All bid must accompanied with 3% of total bid price as bid security for each tender in the shape of CDR from any scheduled bank from their own Bank Account & must entered the name of firm on CDR and lum sum Call Deposit total amounting to **Rs.2,500 Millions (Rupees Two Million Five Hundred Thousand)** (for each tender) in favour of Project Director GSC SEPCO Sukkur.
 - f. The difference of Call Deposit must be submitted alongwith tender documents at the time of submission of Bids, calculated on total offered Bid.
 - g. Affidavit on judicial stamp paper of Rs.100/- that all attached documents i.e PEC, SRB, NTN, Work Orders, CDRs etc are genuine & the firm for applying tender is not Black listed by any Government/ Autonomous body and No any litigation is pending against the firm, if found fake at any stage, the firm will be held responsible for all consequences, must be signed by owner in original and attested from Oath Commissioner.
 - h. The tenders will be received back on scheduled date & time mentioned against each and will be opened on same date & time. If undersigned or any other committee member of tender opening committee will be out of Headquarter or any announced public holiday, the same tenders will be opened on the next working day.
 - i. The successful lowest bidder shall provide the 10% of the contract price as performance security.
 - j. Provide the Tax Returns for last 03-Years.
 - k. Provide the Bank Statement for last 06-months
3. Price of bidding documents is Rs.5,000/- of each tender (Non Refundable).
4. The deadline date for issuance of bidding documents for all works are 09.05.2025.
5. A complete set of bidding document may be purchased by interested bidder who fulfills the above criteria on submission of a written application on their original letter ped alongwith bid security to the office of Project Director GSC SEPCO alongwith required documents as well as to show the original documents at the time of purchase and sell of tender.
6. Under Rule 33 (1) of PPRA 2004, the SEPCO reserves the all rights to accept or reject any or all the bids or proposals at any time prior to acceptance of bid or proposal.

NOTE:- The contractor must ensure to provide the complete brusher of firm having detail of T&P, Manpower/Engineer, Financial statement of permanent employees etc at the time of issuance of Tender duly Audited through Registered financial consultant.
