Federal Employees Benevolent & Group Insurance Fund (FEB&GIF) invites sealed bids from Principal's Authorized Dealers/Distributors/Partners of HUAWEI having NTN/Sales tax registration, included in FBR Active Taxpayer List (ATL) and Manufacturer Authorization Letter (MAL) for timely renewal of "HUAWEI FIREWALL (USG 6525E-AC) LICENSE" during financial year 2024-25.

1. Bidding will be conducted under National Competitive Bidding pursuant to Single Stage Single envelope procedure as per Rule 36(a) of Public Procurement Rules 2004 and is open to all eligible bidders as defined in the Public Procurement Rules 2004.
2. Bids must be accompanied by a bid security @5% in the shape/form of pay order/bank draft in favor of Board of Trustees, FEB&GIF, Islamabad.
3. The Bidders are requested to give their best and final prices as no negotiations shall be allowed. The rates quoted must remain valid for a period of Forty Five (45) days after opening of tenders.

5. Copies of latest registration with Income Tax Department, Sales Tax Department, Proof of Active Tax Payer's List and Manufacturer Authorization Letter (MAL) should be enclosed with bid. Non-submission of this document is liable to declare the bidder non-responsive.
6. Bidders should have Office in Islamabad.
7. Bids received after due date & time will be rejected. Bids submitted without signed Bid Form by authorized nominee of the bidder will also be rejected.
8. Bidders must be registered with E-Pak Acquisition & Disposal System of PPRA and bids must be submitted through EPADS portal of PPRA.
9. FEB&GIF reserves the right to accept or reject any Bid, and to cancel the process of competition and reject all Bids, at any time prior to the award of the Contract.
