NOTES/SPECIFICATIONS / INSTRUCTIONS

1. Suppliers shall furnish name and address of their manufacturers companies.
2. Suppliers shall quote price on their letter head indicating clearly make, price, and quality, otherwise their offer will not be entertained.
3. Suppliers shall submit certificate of registration with the health department (Drug License Holder) otherwise offer will not be entertained.
4. The suppliers shall confirm categorically that they will supply the medicines with date of expiry and date of manufacturing as under:-
Date of manufacturing Jun 2023
Date of Expiry 30 Jun 2026.
5. Quarterly purchase orders will be issued on availability / allotment of funds.

SPECIAL INSTRUCTIONS

1. Suppliers are required to submit their National Income Tax Number, Cable Number and Photo copy of National Identity Card of proprietor / managing director with their tender filling otherwise offer will be ignored straight away.
2. Tenderers shall send their offers with full details, incomplete offer will be rejected straight away.
3. It should be noted that if the store inspected and released by the inspecting officer are rejected either the consignee or the actual user/consumer and on re-inspection of such stores by the inspecting authority it is concluded that rejection is justified by terms and conditions of the contract applicable to such rejection as well, the decision of the inspecting authority regarding such rejection will be final and binding.
4. The department reserves the right to reject the part or whole of any or all tenders with reasons.
5. Overwriting or tampering of tenders is not acceptable.
6. Supplier shall be bound to replace such store or subsequently found defective during the use.
7. Testing fee of bulk supply sample shall be on the account of firms concerned shall be payable by the tenderers.
8. Each page of the tender inquiry shall be signed by tenderers.
9. Registered firms should submit the photocopy of valid registration certificate with their offer.
10. All firms shall deposit 5% earnest money alongwith tender form in the shape of Bank Draft / Pay Order in favour of Director General Pakistan Rangers (Punjab) Lahore, otherwise quotation will not be accepted.
11. The successful tenders while claiming payment for supplies will furnish documentary proof that excise duty has been paid by him for the stores being supplied.
12. The suppliers must quote their firms and final prices inclusive of all duties and taxes on the basis of free delivery to consignee at Lahore.
13. The store will be provided to Pakistan Rangers Veterinary Branch at Zarrar Shaheed Road Lahore on free delivery basis by 25 Oct 2023.
