4. Firms / Contractors who are enlisted with MES in Category A, B, C, D & E and also having experience of this type should only apply.

5. The accepting officer reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
