TERMS AND CONDITIONS FOR BIDDERS


- 1 No tender will be sold / received by post / telephonically or email on the date of opening of tenders.
- 2 According to PPRA Rule 25, Bid security / earnest money mentioned above against each work (03% CDR of approved cost in original must be attached with application at the time of purchase of tender after payment of tender cost (Non refundable) and balance must be attached with bidding documents) in shape of CDR/Call/Pay Order/Band Guarantee deposit from any Scheduled Bank of Pakistan, clearly mentioned the name of firm in favour of Executive Engineer, Central Civil Division Pak.PWD Multan.
- 3 No tender will be issued to the contractor without submission of requisite Bid security mentioned above against each work (in original) from the firm / the company's owned account and mentioning firm's name from any Scheduled Bank of Pakistan in the name of the Executive Engineer, Central Civil Division Pak.PWD Multan.
- 4 In case of quoting rates below than the NIT amount bidder will have to provide additional CDR equal to difference of Estimated amount and bid amount for the respective work from Scheduled Bank of Pakistan in favour of the Executive Engineer, Central Civil Division Pak.PWD Multan if the bidder quoted rate.
- 5 Pay Order / Demand Draft/Bank Guarantee from firm's on Account in favour of Executive Engineer Central Civil Division Pak. PWD, Multan will be accepted.
- 6 If the contractor disfigure/disrupt his tenders, his Call Deposit Receipt/ Pay Order/Band Guarantee will be forfeited in favour of the Governemnt of Pakistan besides punitive action as per Rules.
- 7 All CDR's/Pay Order/Band Guarantee once received will be credited into the Government Account, and will be refunded through Government cheque.
- 8 Undertaking on Stamp paper of Rs.100/- that the Firm/Contractor has neither abandoned any work nor blacklisted in any Department along with Certificate that the Particular / Information furnished are ture and correct duly signed by the Notary Public.
