#### 1. INTRODUCTION:

The National Vocational and Technical Training Commission (NAVTTC) is seeking proposals for staff augmentation to enhance operational capacities within our IT department.   - Develop and execute test plans and test cases.

  - Mentor junior QA engineers.

# 8. TERMS AND CONDITIONS FOR MONTHLY PAYMENTS:

- Monthly Invoicing: The vendor will submit detailed invoices monthly, including the hours worked by each staff member and the applicable rates as agreed in the contract.
- Payment Terms: Payments will be made within 30 days of invoice receipt, subject
  to verifying the work performed. Invoices must be accompanied by timesheets
  approved by the designated NAVTTC manager.
- 3. Performance Review: Monthly payments will be contingent upon satisfactory performance reviews conducted by NAVTTC supervisors. Performance not meeting the agreed standards may result in payment adjustments or contract terms.
- 4. Dispute Resolution: Any discrepancies in invoicing or payments will be addressed through a formal dispute resolution process outlined in the contract.
- 5. Adjustments for Non-performance: We take service levels and downtime seriously. If any unmet service levels or downtime occur, payment adjustments will be calculated pro-rata and deducted from the monthly payments. This policy underscores our commitment to receiving high-quality services and encourages vendors to maintain the agreed service levels.

and other associated costs. The selected firm shall provide a detailed cost proposal as part of their response to these Terms of reference.

#### 12. EVALUATION AND SELECTION:
