- vi. The Contractors/Firms must have completed on-gird Net-metering based installation of Solar Power System (as the main contractor, JV partner) in the last two (02) years with accumulative minimum capacity of 250 KW or above, either as a single or multiple projects.
- vii. All bids accompanied by a Bid Security amounting to Rs.800,000/- (Rupees Eight Lac) in shape of pay-order issued in favor of DDO IBD, Islamabad, must reach at the office on or before 09 May 2025 at 12:00 PM. And scanned copy of the pay-order must be uploaded on EPADS.
- viii. The Technical Bids will be opened on the same day at 12:30 PM in the presence of the bidders' representative who choose to attend at the same address.
