F.No 1(5) S-I/2024-25 (F). Sealed tenders are invited from the firms/Authorized Dealers having proper offices and telephone facility, duly registered with sales tax authorities along with vendor number /NTN Number and also having Sale/Service Center in Islamabad /Rawalpindi for supply of Furniture. Tender can also be downloaded from the websites of Ministry of Finance www.finance.gov.pk and Public Procurement Regulatory Authority www.ppra.gov.pk as well as EPADS.

- i. Rates to be quoted shall be inclusive of GST and all taxes and shall be valid upto balance period of 2024-25 and 2025-26.
- ii. Samples of items, where possible, should be attached/displayed (at their own expenses) in Q Block Ground Floor two days prior to opening the Tender otherwise offer will not be entertained.
- iii. The firms shall be liable to supply the requisite items at Q Block, Pak secretariat, Islamabad, at their own expenses and even at short notice if needed failing which the security deposit of the firm shall be forfeited and the firms shall be blacklisted.
- iv. The offered product must be compliant with the required specification,
- v. Earnest/Security Money Deposit amounting to Rs. 500,000/- in the shape of Pay order for purchase of Furniture is required to be deposited in favour of Drawing & Disbursing Officer/Section Officer (Budget & Accounts), Ministry of Finance.
