- x. The successful bidder will have to pay income tax and other charges at prevailing rate rules of concerned department including all CB dues.

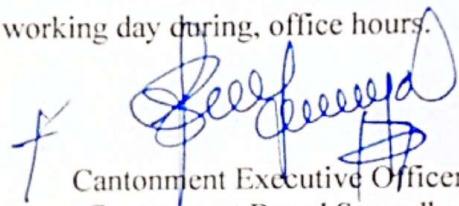

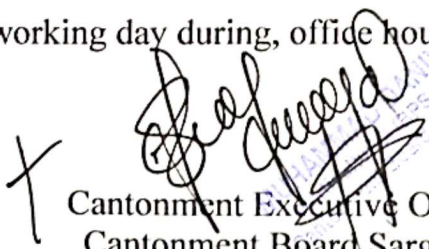
