**CORRIGENDUM**

The following additional terms and conditions are added in the Notice Inviting Tender of the work titled "Construction of Office Building of the Plant Breeders Rights Registry in the Existing Building of FSC&RD, Islamabad. (SH: Construction of Additional 2 Floors (3rd & 4th) on Existing Building of Federal Seed Certification and Registration Department (FSC&RD), G-9/4, Islamabad" vide this office letter No.CCD-III/AB/Advt/381 already advertised in Electronic Media vide TS536963E dated 09-04-2024 and published in print media on 13-04-2024:

1. The Annual Financial Audit report must be produced / enclosed in the Technical bid conducted by firm with Satisfactory QCR rating otherwise the proposal will be rejected.
2. Bank Credit Line of Rs.40.00 Million in original (Scanned/photocopy will not be accepted) must be enclosed in the Technical bid), otherwise the proposal will be rejected. The Bank Credit Line must have a date of issuance after invitation of tender notice in newspaper and on or before tender opening. No Bank Credit Line having a date of issuance prior to invitation of tender will be accepted.
3. The firm will provide Work Order + Completion Certificate for completed projects within last Five (05) year and Work Order for ongoing projects having same worth.
4. The firm must also provide list of all the works in hand irrespective of its worth.
5. If the firm's work experience of similar size and nature is more than the requirement of the criteria, the extra works can be considered for General Construction Experience.
6. To qualify, applicants must receive not less than the specified minimum applicable points (50%) for each category and an aggregate of 70% points out of maximum 100 points.
7. In case of quoting rates below than the estimated value, the bidder will have to provide additional Performance Security in the form of CDR as per IB 28.4, equal to 10% of the NIT Amount for the respective work.
8. The envelope of "**Financial Proposal**" of the bidders who fail to post-qualify technically shall be returned to them unopened. The decision of the competent authority in this connection shall be final and binding on the bidders and the competent authority shall not entertain any claim on the basis of cost incurred by the bidders for preparation of the Bids.
9. The envelope of "**Financial Proposal**" of the firms who shall post-qualify and whose bids shall be technically accepted by the competent authority will be opened in the presence of their respective representative at the date or time to be determined and communicated to them later on through registered post.
10. All CDRs once received, will be credited into the Government account, and will be refunded through Government cheque.
11. The constructors/firms providing forged, fake false, and/or unsubstantiated information will be liable to legal action and/or disqualification/rejection of bids and recommendation for blacklisting.
12. JV is not allowed owing to administrative/ documentary reasons.
