

2. Bid are required to be accompanied with pay order 20,000/- as earnest money in favour of Directorate of Intelligence and Investigation- Customs, Lahore.
3. Bids should reach the above address in sealed envelopes by 11:00 a.m. on 10.06.2025 (Tuesday). Bids will be opened in the presence of bidders or their authorized representatives at 03:00 pm on the same date.
4. The quoted rates must be inclusive of all applicable duties/taxes.
5. The bidders must enclose copies of their NTN certificates and Sales Tax Registration certificates alongwith copy of CNIC
6. Bidding will be conducted on the basis of National Competitive Bidding method under the provisions of Public Procurement Rules 36(a) single stage, one envelop procedure (PPRA-2004)
7. The Directorate reserves the right to reject any or all bids without assigning any reason thereof.
8. No bid shall be entertained after the given cut off date and time.
9. If the bidder is found blacklisted by any organization at any stage during tendering process or execution of the contract, the same shall be cancelled.
