Bidding will be conducted through international competitive procurement using a Request for Bids (RFB) as specified in the World Bank’s “Procurement Regulations for IPF Borrowers” July 2016, revised November 2017 and August 2018 (“Procurement Regulations”), and is open to all eligible Bidders as defined in the Procurement Regulations.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on the same day i.e., **22nd June, 2022** immediately after the bid submission deadline.

All Bids must be accompanied by a **“Pay Order/ Demand Draft/ Call Deposit Receipt”** or **“Bank Guarantee”** equivalent to two percent (2%) of the bid value issued by a scheduled Bank located in Pakistan (for Local Bidders) or country of incorporation/ registration (for International Bidders), as per the details/ requirements given at the respective section(s)/ clause(s).
