- Quotations regarding each items alongwith photocopy of the National Identity Card and 50% of the offered price in the form of pay order or demand draft in favour of Chairman. Auction Committee, Regional Tax Office, Jail Road, Faisalabad must be submitted.
- Furthermore, successful bidders / quotationers will have to pay 50% money on the spot and they will be required to take possession of the items within 3 days of the announcement of results of the auction on complete payment, otherwise, bid will be considered be cancelled and the amount deposited will be forfeited.
