- 4. The bids can only be submitted in electronic format through e-tender portal from the date of publication in newspapers and portal, the deadline for submission of bid is 17/02/2025 at 1400 hours. Bids would be opened on the same day at 1430 PM online.
- "Single stage one envelop E-bidding system will be adopted / followed" envisaged in PPRA Rules.
