1. With reference to above all prospective Individual Consultants are informed that the referred procurement process has been annulled in accordance with PPRA Rule-33.
2. The National Highway Authority (NHA) intends to engage Consultant for "Consultancy Services for "Design Review, In-House Feasibility Study & Detailed Design of National Highway Authority (NHA) Projects- Appointment of Experts" for each category as mentioned below:
  - a) **Geometric Specialist**
  - b) **Pavement Specialist**
  - c) **Quantity Surveying (QS) Specialist**
3. Proposals are invited from reputable Consultants having valid registration certificate from concerned departments alongwith enlistment on Active Tax Payers List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.

RFP documents can be downloaded from NHA's website [www.nha.gov.pk](http://www.nha.gov.pk) free of cost or the same can be purchased from the office of General Manager (P&CA), NHA-HQ, Islamabad during working hours and working days on written request of Individual Consultant letter head accompanied with pay order/demand draft amounting to Rs.1,000/- (nonrefundable) in favor of National Highway Authority.
5. Pre-Proposal Conference will be held on **27<sup>th</sup> December, 2024** at 1100 hours in the NHA Auditorium (HQ) Islamabad. Due to COVID-19, only one authorized representative will attend the pre-proposal meeting as well as proposal opening event.
6. Procurement will be carried out by adopting "Single Stage Two Envelops" procedure. Separate Proposals for respective positions complete in all respects, in accordance with the instructions provided in the RFP document, in sealed envelopes should reach on or **16<sup>th</sup> January, 2025 at 1130 hours** in the office of General Manager (P&CA) NHA-HQ 28-Mauve Area, G-9/1, Islamabad and be clearly marked "Consultancy Services Design Review, In-House Feasibility Study & Detailed Design of National Highway Authority (NHA) Projects- Appointment of Experts [Appointment of Experts: Geometric Specialist or Pavement Specialist or Quantity Surveying (QS) Specialist"]".
7. The technical proposals shall be opened on the same day at **1200 hours**, whereas the financial proposals of the technically qualified Individual Consultant shall be opened after finalization of technical evaluation. Other details are provided in the RFP document against the relevant position.
