The applications shall be scrutinized and the tender documents will only be issued to the firm who have sufficient experience in relevant field and satisfy other special conditions required for the job and area. Tender will only be issued to the prequalified contractors. The tenders must be received in the office of accepting officer by **20 Mar 2025** at 1130 hrs and will be opened at 1200 hrs on the same date.

NOTE: - Contractors shall provide certificate that they are not involved in any type of litigation with Govt Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration certificate. Contractors not registered with PEC are ineligible to apply.

4. Contractors borne on approved list of MES in Category A, B & C and also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.

7. The interested parties can contact CMES concerned/authorized representative for further details from 0800 to 1500 hours on all working days.
