 - iv. Bidding documents will not be issued who have blacklisted.
 - v. Conditional bid will not be accepted.
 - vi. Unbalance quoted rates will be dealt as per rule/policy.
 - vii. The Procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under the provision of Rule-33 of PPRA Rules 2004.
