Executive Engineer (Civil) / In-Charge, Khanpur Dam Project (WAPDA), Khanpur, District Haripur (Hazara), Khyber Pakhtunkhwa, invites electronic bids from contractors registered with Income Tax and Sales Tax Department as well as licensed by the Pakistan Engineering Council in Category **“C-6 or above” sub code CE-10** for **“Installation of Barbed Wire Fencing and Barriers at Malkanwala Dyke Points 1 and 2, Old Khanpur Area Point No. 3 and Near the Main Gate of Khanpur Dam Project”**.

Single Stage one envelope procedure shall be followed for this procurement.

4. Each bidder shall furnish a Bid Security of **PKR 115,000/-** in the form of CDR in favor of the Executive Engineer (Civil) / In-Charge, Khanpur Dam Project (WAPDA).
