

1. The office of Director Civil Works POF Wah Cantt invites sealed tenders for the following works as per Single-Stage: One-Envelope Bidding Procedure, in the light of PPRA rule.

2. The contractors are required to submit their applications (**Separately for each work**) to Director Civil Works, Quaid Avenue, POF Wah Cantt upto the dates mentioned against each work for issuance of tender documents alongwith their complete credentials as shown below. Contractors who are on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax are eligible to submit their applications.
3. The applications shall be scrutinized and the tender documents will only be issued to the contractors who have sufficient experience in the relevant field and satisfied other special conditions required for the job and area. Tenders will be received in Bid Centre adjacent with Rabta Hall POFs Wah Cantt upto 1000 hrs on the dates mentioned against each work and will be opened at 1030 hrs on the same date. In case of Public Holiday, tenders will be received on next working day upto 1000 hrs and will be opened at 1030 hrs on the same day.
4. Contractors having experience, capability and resources may submit the following information/documents alongwith their applications: -
- a. Valid P.E.C Registration as mentioned against each.

- b. Firms will furnish resources details i.e list of personnel, Bank statement, plants & machinery and similar nature of works completed during last three years with POFs or other Organizations / Departments.
 - c. Similar nature of works in hand alongwith names and addresses of clients.
 - d. NTN No. and STRN No. and evidence of as active tax payers on Active Taxpayers List (ATL) of FBR for Income Tax & Sales Tax.
 - e. Affidavits on E-Stamp paper that the firm is not blacklisted and not involved in any litigation with any Organizations / Departments.
5. Those who fail to provide above mentioned Information / documents shall be disqualified and Cutting / over writing of offered rate / cost will not be accepted and tender of the firm will be rejected.
6. The Authority reserves the right to reject any or all the pre-qualification applications under provision of PPRA Rules.
