Contractors **NOT BORNE** on MES approved list of contractors or **THOSE SUSPENDED** from the approved list of MES Contractors due to non depositing enhanced amount of standing security will deposit earnest money equal to 2% of the above mentioned estimated cost in the form of FDR, Deposit At Call etc duly pledged in the name of CMES (Navy) COMCOAST. This amount is refundable; if the contractors are not pre-qualified/they do not secure the contract.
