## INVITATION TO E-BID

Northern Power Generation Company Limited (GENCO-III) was created as part of a major restructuring initiative in Pakistan's power sector. The government of Pakistan, in an effort to improve the efficiency and management of its electricity generation, decided to restructure the Water and Power Development Authority (WAPDA) in the early 1990s. WAPDA, which was originally responsible for all aspects of power generation, transmission, and distribution across the country, was divided into multiple entities to improve specialization, accountability, and operational efficiency. As a result, several generation companies were established under the umbrella of WAPDA, including NPGCL.

- NPGCL (The Employer) invites e-bids (As per PPRA Rule 36(a) Single Stage Single Envelope) from the Manufacturer/Dealers/Sole Distributers/Supplier (Firm Registered/Un-Registered with WAPDA) (Procurement of transportation and loading charges for shifting of furnace oil from SPS, Faisalabad to, TPS, Muzaffargarh.) Supplier should be registered with Income Tax and Sales Tax Departments.
- 2. E-bidding documents as per regulations, containing detail terms and conditions, specifications and requirements etc. are available for the registered bidders on EPADS at <u>https://eprocure.gov.pk</u> as well as available at the address mentioned at Sr. 5 on the price of PKR 1,000 (Pak Rupees One Thousand only). Bidders must submit price bid through E-Pak Acquisition & Disposal System (EPADS). Price Bid must be accompanied by a scanned copy of Bid Security of fixed amount of Rs. <u>90,000.00</u> in favour of NPGCL (GENCO-III) in the shape of Pay Order/ CDR; original shall be submitted in the office of Manager (Supply Chain), TPS Muzaffargarh along with other necessary documents as mentioned in bidding documents.
- 3. The bids, prepared in accordance with the instructions in the bidding documents, must be uploaded on EPADS on or before 12 May, 2025 at 1130 hours. Only Bids received through EPADS will entertain and no manual bid will be accepted. Bids will be opened on the same day at 1200 hours in the office of Manager (Supply Chain) TPS Muzaffargarh.
- 4. The Employer reserves the right to annul the bidding process and reject all Bids, at any time prior to award of the Contract, in accordance with Rule **33** of Public **Procurement Rules, 2004**
