## TENDER NOTICE


Walton Cantonment Board being procuring entity invites sealed bids as per "Single Stage Two Envelop Procedure under Rule 36(b) of PPRA Rule 2004 (as amended upto date) for procurement of medicine / local purchase for the period of financial year 2023-24 by offering unconditional discount on retail price in percentage to Walton Cantonment Board dispensaries located at RA Bazaar, Pir Colony and Shoukat Town from licensed pharmaceutical firms / authorized distributors registered with Ministry of Health, Income Tax & Sale Tax department and are on active taxpayers list of the Federal Board of Revenue.

### TERMS AND CONDITIONS:

1. Bidding documents / Tender forms can be obtained on the cost of Rs.1,000/- on submission of applications from the date of publication of advertisement on PPRA website but not later than **07-09-2023**.
2. The Suppliers / Distributors shall offer maximum percentage of rebate on retail price and medicine will not be accepted from pharmaceuticals companies which are not registered with Ministry of Health of Pakistan.
3. Bidding documents will be deposited in tender box (to be placed in front of office of the Assistant Secretaries, Walton Cantt Board, R.A. Bazar Ahmed Bukhsh Road, Lahore Cantt) on **12/09/2023** till 1300 Hours. Technical Bid will be opened on the same date at 1330 Hours in the presence of the bidders or their authorized agents. The technical bids will be evaluated by the committee.
4. Financial bid of successful / qualified bidders will be opened after 07 days of the opening of technical of bid.
5. Financial bid will not be entertained without call deposit amounting to Rs.300000/- in the favour of Cantt Executive Officer, Walton Cantt.
6. Tender bidding documents containing invitation to the bid / tender notice, instructions to bidders, Form of Bid, Conditions of Contract Agreement Specifications, Bill of Quantities of medicine and Bid evaluation criteria etc. can be obtained on any working day during office hours from the office of Walton Cantonment Board RA Bazar Ahmed Bakhsh Road Lahore on or before closing date / time of tender bid. 7. Tender will be issued those firms who have valid (CDSL) Central drug sale license are on active taxpayers list of the Federal Board of Revenue.

8. The **“Technical Proposal / Bids”** of the firms / contractor will be evaluated in accordance with evaluation criteria as laid down in bidding documents.

The **“Financial Bids / Proposal”** of only technically responsive bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representatives (who may like to attend) in the office of the Walton Cantonment Board on date and time to be notified later on whereas the Financial Bids of technically non-responsive bidders shall be returned unopened to the respective contractors.
10. The validity of tender rates shall be upto 12 Months.
11. Other terms & conditions pertaining to the work can be seen in the office of the Walton Cantonment Board at any working day during office hours.
12. Supply order shall be issued subject to the approval of Competent authority.
13. All the Government taxes will be deducted as per prevailing Government policy.
