TERMS & CONDITIONS

01. Sealed tenders containing technical and financial proposal in separate envelopes must be submitted to undersigned on the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representatives at Governor's House Gilgit-Baltistan, Gilgit.
02. Contractors/Suppliers may offer only for that category of tender in which they have complete setup with all documentary evidence.
03. Tender for each category must be offered mentioning name of category in bold letters on sealed envelope.
04. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of **Military Secretary to Governor Gilgit-Baltistan** may be attached with the technical documents. Tender without call deposit from a schedule bank will not be entertained.
05. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained.
06. The rates of items if not enlisted in the "Prescribed Form" will be determined in accordance with the prevailing retail price/market rate at the time of supply.
07. Bank Statement, five year work experience in relevant field, firm registration certificate, Non Black Listed Affidavit, CNIC of the owner, Letter Pad of Firm with address, Vender Number & Telephone Number must be attached with technical bidding documents duly attested.
08. Irrational/artificial and dubious rates offered by the firms/contactors will be rejected.
09. All kind of taxes applicable (if any) will be inclusive in the bid price and borne by the firms/dealers/suppliers/contractors.
10. The Competent Authority reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of PPRA/GB PPRA.
