TENDER NOTICE SOLID WASTE MANAGEMENT

Sealed proposals / bids are invited from well experienced Contractors/ Firms having 10 years experience of working in the field of Municipal Solid Waste Management, registered with Inland Revenue Department, for hiring of the similar services in area of Walton Cantonment Board. The interested contractors/ firms are required to submit their bids through SINGLE STAGE TWO ENVELOPES procedure as outlined in rules 36(b) of the PPRA Rules, 2004. Each envelope shall contain separately the TECHNICAL PROPOSAL & FINANCIAL PROPOSAL and shall be marked as such in bold and legible letters to avoid any confusion. The bid validity period shall be one hundred eighty (180) working days after the bid is received and opened.

A. SCOPE OF WORKS:

The contractor shall be responsible for the following works.

- 1. Collection, transportation and safe disposal at location specified by WCB of municipal solid waste from different sectors of WCB area.
- 2. The services shall also include cleaning of roads, nullahs, open areas and removal horticulture waste, dead animals and debris etc in areas of operations.
- 3. The job includes hiring cost of all equipment, accessories & labor.
- 4. The contract period shall be three years extendable further on mutual consent.

B. EVALUATION CRITERION:

The evaluation committee of WCB shall first scrutinize the technical proposal based on evaluation criteria given in bid documents while retaining the financial proposal. The mandatory documents required along with technical proposal are mentioned as under. However, additional documents in support of your bid may also be provided.

- (a) Company profile with details of its establishment, relevant experience, HR & managerial capabilities required for the project.
- (b) Past performance / experience of similar nature of contractors.
- (c) Financial position & Tax Turnovers.

C. FINANCIAL EVALUATION

Only short listed Technically qualified contractors / firms shall be called for opening of financial bid which shall be opened in the presence of parties / firms or their authorized representatives who wish to be present on the given date and time.

D. SUBMISSION OF TENDER:

- 1. Closing date for tenders to reach in the Office of Walton Cantonment Board, Ahmed Bukhsh Road Lahore is on **21-02-2024** at **01:00 pm** and shall be opened on same day at 02:00 pm in presence of contractors or their authorized representatives who happened to be present at that time. The tender received late will not be entertained.
- 2. Conditional / posted/ telegraphically dispatched tender will not be accepted.
- 3. The outside of the envelope should be inscribed with Name of work and date of advertisement.
- 4. Tender documents can be obtained from the Office of Public Health Officer, Cantonment Board Walton Ahmed Bukhsh Road, Lahore during the office hours on payment of Rs.10,000/- (Non Refundable) immediately after publication of this notice.

E. GENERAL INSTRUCTIONS:

- 1. Tender shall be accompanied by bid security as specified against each Sector in tender documents in the shape of Pay Order / Bid Bond in the name of Executive Officer, Walton Cantonment, Walton and will be attached with Technical bid.
- 2. The quoted rate in FINANCIAL PROPOSAL should be free from any cutting, erasing and overwriting etc.
- 3. No materials, tools, labour, or plants will be supplied by the WCB.
- 4. All those bidders who are black listed by any Government Department are not eligible for the bidding.
- 5. To clarify and discuss issues with respect to the CONTRACT and Bidding, WCB may hold pre-bid meetings(s).
- 6. The composite score under the Technical Proposal would be the arithmetic sum of the marks assigned to the bidders under each of parameters listed in Clause 15.2 of the Bidding Documents.
- 7. The rate for each sector shall be quoted separately on prescribed format attached in bidding documents.
- 8. The attested copy of vehicle registrations owned must be provided for issuance of tender as per bidding documents.
- 9. All the vehicles to be provided by the Contractor should be of 2018 model or above.
