 - Constructors/Firms should provide 3% bid security in shape of (CDR/TDR) in the name of Executive Engineer B&R Division GB PWD Nagar from any schedule bank of Pakistan.
 - Bid security(CDR/TDR) shall provide to department for verification of relevant bank.
 - Bidding documents shall not be issued to constructors who have delayed already awarded projects.
 - Bidding documents will not be issued who have blacklisted.
 - Conditional bid shall not be acceptable to the department.
 - Unbalance quoted rates will be dealt as per rule/policy mentioned in bidding documents.
 - The Bidder quoting rates below 10% shall provide Performance Guarantee of 100% of the Differential amount in shape of CDR from a schedule Bank.
 - The procuring agency may reject all bids or proposals at any time prior to the acceptance of a bid or proposal under the provision of Rule-33 of PPRA Rules 2004.
 - The interested bidder shall provide undertaking certificate on Judicial Stamp Paper prescribed format attached in bidding documents.
