

Terms and Conditions:-

- i. Interested bidders can only submit their bids online through E- Tender portal of ML&C department (<https://etender.mlc.gov.pk>).
- ii. Contractors having valid NTN No. and register with PEC in the relevant category & limit are eligible to apply.
- iii. The bids can only be submitted in electronic format through E-Tender portal from 23/10/2023 at 11:00 am, the deadline for submission of bid is 23/11/2023 at 11:00 am. Bids would be opened on 23/11/2023 at 02:30 pm. No manual Tender shall be entertained.
- iv. E-Tender without attachment of call deposit / bond in favor of the undersigned as earnest money will be rejected.
- v. The CDR,s / Bids Security /earnest money (fixed amount) uploaded online shall be also be deposited (in original) in CBS office (CB Care Centre) on same day prior to cut off time in shape of demand draft / CDR/ Pay order before opening of bids as per PPRA Rule No.25. In case of failure the bidder shall not be qualified for bids opening and shall be liable to face the consequences of forfeiture and blacklisting for sabotaging the tendering process.
- vi. The bid security /earnest money of successful bidder will be refund after expiry of defect liability period i.e.01 year after completion of work OR successful completion of audit which ever later.
- vii. The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their responsibility and workability.
- viii. The Cantonment Board / Executive Officer reserve the right to reject (prior to approval) the tender as per PPRA, s Rule No.33 due to any reason thereof.
- ix. The validity of bid rates shall be upto 180 days as per PPRA /PEC Rules.
- x. The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with CB Sargodha within 07 days of issuance of acceptance letter.
- xi. The successful bidder will be responsible to supply and fixing of articles as per directions.
- xii. The issuance of work order shall be subject to approval from Board.
- xiii. Any information regarding the E-Tender can obtained from the office of undersigned during office hours.
- xiv. No cheque / cash will be acceptable.
- xv. Conditional /multioptional tender / quotation will not be acceptable.
- xvi. All PPRA Rules and Govt. Taxes (in vogue for the time being) are applicable.
- xvii. Any tools / machinery kind of store / mobilization advance for execution of job will not be provided by CBS.
