05 Contractor born on approved list of MES in category 'A', 'B', 'C', 'D' & 'E' and also having experience of this type of work may only apply.

06 Contractor who desire my present at the time of opening of tenders.

07 The accepting officers reserve the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA Rules.
