QUOTATION NOTICE

Cantonment Board Rawalpindi being procuring entity invites sealed Quotation / bids (on prescribed Bidding Documents) accompanied by earnest money of (2% of total bid) in the shape of Demand Draft / Pay Order / Call Deposits / Bank Guarantee / Insurance Guarantee from any Scheduled Bank / Insurance Company (as per Rule 25 of PPRA Rules 2004) in favour of Executive Officer, Rawalpindi Cantonment on market item rate basis as per **"Single Stage Two Envelope Procedure"** under Rule 36(b) and 12(1) of PPRA Rule 2004 (as amended upto date) having expertise in relevant field and also are on Active Taxpayers List of the Federal Board of Revenue for execution of following work: -

1	Desilting / Cleaning of Left Bank Canal (LBC) (Mechanically and Manually) complete in all respect including food for 90x employees on daily basis.

TERMS AND CONDITIONS:

1. Bidding documents / Tender forms can be obtained on the cost of Rs.1,000/- on submission of applications from the date of publication of advertisement in PPRA Website but not later than 07/03/2024.
2. Bidding documents will be deposited in tender box (to be placed in front of office of the Asstt. Secretary, Rawalpindi Cantt Board, the Mall Rawalpindi Cantt) on 12/03/2024 till 1330 HRS. Technical Bid will be opened on the same date at 1400 HRS. in the presence of the bidders or their authorized agents.
3. Financial bid of successful / qualified bidders will be opened within 10 days of the opening of technical bid.
4. Tender / Bidding documents can be obtained on any working day during office hours from the office of Cantonment Board Rawalpindi at The Mall Saddar Rawalpindi Cantt on or before closing date / time of tender bid. Price of bidding document as per Tender Notice (non-refundable).
5. The **"Technical Proposals / Bids"** of the firms / contractors will be evaluated in accordance with laid down evaluation criteria mentioned in bidding documents.
6. The **Financial Bids / Proposals** of only technically responsive bidders will be opened after evaluation of Technical Bids in the presence of bidders / their representatives (who may like to attend) in the office of the Cantonment Board Rawalpindi on the date &

time to be notified later on whereas the Financial Bids of technically non-responsive bidders shall be returned unopened to the respective contractors.

7. The validity of Tender rates shall be minimum upto 180 days as per PPRA / PEC Rules.
8. The Cantonment Board reserves the right of demanding the analysis of the quoted rates from concerned bidder, to check their responsibility and workability.
9. The quantum of work may vary as per PPRA Rules and lowest bidders shall be bound to execute the work on similar rates / terms & conditions.
10. Conditional / incomplete tenders / bidding documents wherein necessary details are missing will not be accepted.
11. Successful tenderer shall have to execute an agreement (at their own cost) on non-judicial stamp paper of appropriate value for faithful execution of the contract.
12. Other terms & conditions pertaining to the works can be seen in the Office of the Cantonment Board Rawalpindi at any working day during office hours.
13. Rawalpindi Cantonment Board / Executive Officer reserves the right to accept or reject all tenders (prior to acceptance) as per PPRA's Rules No.33 (1) due to any reason thereof.
