The Pakistan Water and Power Development Authority (WAPDA) (the "Purchaser") invites sealed bids, under single-stage one-envelop bidding procedure, from original manufacturers/ suppliers/ contractors as defined under Clause IB.3 of Instruction to Bidder, registered with Income Tax and Sales Tax Departments and who are on Active Taxpayers List of the Federal Board of Revenue, for Supply, Installation & Commissioning of Diesel Generator sets in two lots for 2nd Rehab Project WAPDA Warsak on F.C.S Basis which includes, the following: -
