TERMS AND CONDITIONS: -

- Sealed tender forms may be submitted to undersigned before the closing date and time, which will be opened by the committee on above mentioned date and time in presence of the contractors/suppliers or their authorized representative at DC office Ghanche.
- 2. The contractor / supplier must adequate supply/ stock in Ghanche and the firm will be bound to supply demanded items and same rates as well.
- 3. Envelope containing technical and financial proposal must be submitted before the closing date and time accordingly.
- 4. The bid security/call deposit (refundable) in shape of bank draft by a schedule bank in the name of Casher DC Office Ghanche attached with the (technical Documents) bidding/tender documents. Tender without call deposit from a schedule bank will not be entertained.
- 5. The bidding documents of only registered firms/dealers/suppliers/contractors will be entertained (attached attested copies)
- 6. The rates of items of not enlisted in the "Prescribe Form" will be determined in accordance with the prevailing retail price /market rate at the time of supply. The contractor /supplier will not have to right the challenge the market rates collected from the market by the concerned staff of the DC office Ghanche.
- 7. Conditional, ambiguous and incomplete tender documents will not be accepted.
- 8. 02 year experience in relevant field, firm registration certificate, cnic of the owner, letter pad of firm with address, vendor No and telephone must be attached with technical bidding documents duly attested.
- 9. Irrational/artificial and dubious rates offered by the firm/contractor will be rejected.

- 10. All kind of taxes applicable (if any) will be inclusive in the bid price and bound by the firms/dealers/suppliers/contractors.
- 11. The competent authority reserves the right to accept or reject any one or all the tenders as per relevant instructions/guidelines of PPRA.
- 12. Firms at least two supply orders of work completion of similar nature, size and complexity as contractor.
- 13. Exaggerated rate above 10% from market rate will be supposed rejected.
- 14. The tender rates list provided by the firm to this department must be in computerized print form with signatures. Hand written tender rates list with cuttings will not be accepted.
- 15. No bidding document will be issued through post, telegraph or E-Mail and on day of opening. The undersigned in accordance with PPRA Rule-33 of 2004 may reject all bids or proposals any time prior to the acceptance of a bid or proposal.
- 16. The rates of items of not enlisted in the "Prescribe Form" will be determined in accordance with the prevailing retail price /market rate at the time of supply. The contractor /supplier will not have to right the challenge the market rates collected from the market by the concerned staff of the DDMA office Ghanche.
