

- Contractor/ firms shall provide 02% E/money of estimated cost in shape of deposit at call in the name of Director Water Management & Irrigation GB, from any schedule bank of Pakistan.
- Overwriting on bidding documents is not allowed and incase of any overwriting/omissions is found, the bid shall be rejected.
- Contractor/ Firm shall provide certificates of no litigation, no nay sick project with any other Govt. Department.
- Rate quoted below of the Technical Sanction shall be considered as unworkable, however:-
 - The bidder quoting rates below 10% of the TS amount shall be required to provide along with his bids an additional performance guarantee of 50% of the differential amount (between TS and Bid) in shape of CDR.
 - In case of failure to produce the required differential amount of the bid by the bidder along with his bid documents, the bid shall be rejected.
