**NOTICE INVITING TENDER**

Sealed tender/bid (single stage two envelopes) on percentage rate basis are invited from well reputed/experienced contractors/firms registered with PEC in category C-5 and above (**having relevant codes of specialization & Electrical License**) for the current financial year. The contractors/firms should be registered with Income Tax Department as active taxpayers. Tender will be issued to proprietors of the firms, companies and their legally authorized representatives having special power of attorney registered with concerned registrar and specifically mentioning the name under mentioned work.

**TERMS & CONDITIONS:**

1. Interested firms/bidders may purchase the bidding documents upto **13/06/2022** during working hours (08:00 hrs to 15:00 hrs) from office of the undersigned on written request of company letter pad accompanied with attested copy of CNIC, Income Tax registration certificate as active payer.
2. Technical & Financial bids are to be submitted at the address mentioned below by 12:00 hrs upto **14/06/2022**. The envelope containing Technical Bid shall be opened on the same date at 12:30 hrs in the presence of bidders or their authorized representatives.
3. Bidding documents will be issued to eligible firms based on their written application which must be accompanied with bid security as mentioned below in shape of deposit at call/CDR from any Schedule Bank of Pakistan in favour of "**Executive Engineer, Project Civil Division No.IV Pak.P.W.D.Islamabad**" issued by any scheduled bank functioning at Islamabad /Rawalpindi from the account of applicant firm must be submitted at the time of purchase of bidding documents.
4. "Single stage, two envelopes" bidding procedure shall be adopted. Envelopes containing technical information of bids must be clearly marked as "**Technical Bid**" and envelope containing bided price must be clearly marked as "**Financial Bid**".
5. In the first instance, the "**Technical Proposal**" shall be opened and the envelope marked as "**Financial Proposal**" shall be retained unopened in the custody of the procuring agency.
6. During the technical evaluation, no amendments in the technical proposal shall be permitted.
7. After the evaluation and approval of the technical proposal, the procuring agency shall open in the presence of intending bidders, the financial proposal of the technically accepted bids, at time, date & venue announced and communicated to the bidders in advance, within the bid validity period.
8. The financial bids found technically non-responsive shall be returned un-opened to respective bidders.
9. The procuring agency shall evaluate the technical proposal in the manner prescribed in bidding documents, without reference to the price and shall reject any proposal which does not conform to the specified requirements.
10. No tender will be sold by post/telephonically or on the date of opening of tender. In case of public holiday, the sale and opening will be changed to next working day.
11. A pre-bid meeting will be held on **06/06/2022** at 11:00 AM in **Project Civil Division No.IV Pak.P.W.D.Islamabad**.
12. All the applicable federal/provincial and local taxes must be considered while preparing the financial proposals and are required to be built in the quoted rates. The bidders, providing fake, false and forged information shall be liable to disqualification.
13. Partial, incomplete and conditional bid will not be entertained.

17. A certificate duly authenticated by Oath Commissioner on judicial stamp paper of Rs.100 to the effect that all documents and particulars/information furnished by the firm are true and correct, should be provided with technical bid.
