- According to PPRA Rule 25, Bid security / earnest money mentioned above against each work in original must be attached with bidding documents/ tender in shape of CDR/ Call / Pay Order/ Band Guarantee prepared from the firm / company's owned account and mentioning firm's name from any Scheduled Bank of Pakistan, in favour of Executive Engineer, Central Civil Division Pak.PWD Multan.
- Without requisite Bid security mentioned above against each work (in original), tender will not be entertained.
- In case of quoting rates below than the NIT amount bidder will have to provide additional CDR equal to difference of Engineer Estimated amount and bid amount for the respective work from Scheduled Bank of Pakistan in favour of the Executive Engineer, Central Civil Division Pak.PWD Multan.
- If the contractor disfigure/ disrupt his tenders, his Call Deposit Receipt/ Pay Order/ Band Guarantee will be forfeited in favour of the Government of Pakistan besides punitive action as per Rules.
- CDR's/ Pay Order/ Band Guarantee of 1st Lowest bidder will be credited into the Government Account.
- Undertaking on Stamp paper of Rs.100/- that the Firm/ Contractor has neither abandoned any work nor blacklisted in any Department along with Certificate that the Particular / Information furnished are true and correct duly signed by the Notary Public.
- The documents provided by the bidders will be verified and in case of fake one the firm will face immediate / appropriate penal action as per rules and law.
- The bidder will be required to give a detailed analysis of workability of his bid if deemed necessary.
- The submission of tenders by the contractors implies that he is fully conversant with the site of work, scope of work and terms and conditions as laid down in the tender documents.
- Under Rule 33(1) of Public Procurement Rules, 2004, the competent authority reserve the right to reject all bids or proposals at any time prior to the acceptance of bid or proposal.

- Applicant must have completed / in hand at least two (02) projects of similar nature having same magnitude in last 02 years (For completed projects completion certificate of taking over certificate from concerned authority or engineer in charge reflecting the type and value of project to be attached)
