01. The office of DW&CE (PAF) Chaklala invites sealed tenders for the following Works in light of **PPRA Rule 13 (1) of 2004:-**

03. Firms will furnish details including work orders, location and pictures of completed projects alongwith satisfactory completion certificate from user. Firms having experience in Construction, Electrical, Mechanical, Plumbing works / services registered with PEC irrelevant filed are eligible to apply.

NOTE:- Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

04. Firms will furnish list of personnel, Bank statement, NTN certificate, Income tax return for the last three years.

05. Only those firms / contractors can apply who fulfill the under mentioned criteria: -

- Enlisted with PEC in Cat C-5 & above in the relevant filed with validity at least up to Jun, 2024.
- Preferably Enlisted with MES in Cat A. In case of non-enlisted firms, 2% bid security will be provided (Refundable).
- No Special report of DI&E & no outstanding DI&E recoveries.

06. Tender will be issued to Pre-qualified firms / contractors and are required to be received in HQ DW & CE (PAF) Chaklala at 1130 hours on **16 May, 2025** and will be opened on the same date at 1200 hours.

07. **Bidding Documents: -**

- Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid.
- The procuring agency shall provide a set of bidding documents to any supplier or contractor, on request and subject to payment of price, if any.

Explanation: - For the purpose of this Sub-Rule price means the cost of printing and providing the documents only.

08. Incomplete application shall not be entertained.

09. The Accepting Officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33(1) of PPRA Rules.
