The applications shall be scrutinized and the tender documents will only be issued to the firm who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will only be issued to the scrutinized contractors. The tender must be received in the office of accepting officer by **16-May-2025** till **1130 Hrs** and will be opened on the same date at **1200 hours**.

3. All contractors, will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractor born on approved list of MES in category 'E' and above and also having experience of this type should only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per para 33 (i) of PPRA Rules.

7. The interested parties can contact GE (Army)-1 Sialkot / authorized representative for further details from 0800 to 1300 hours on all working days.
