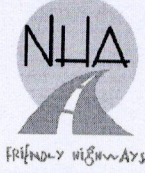

Proposals are invited from reputable Consultants (Engineering Organizations/ Firms) having valid Pakistan Engineering Council (PEC) registration certificate in relevant field along with enlistment on active Tax Payer List of Federal Board of Revenue and the detail eligibility criteria mentioned in the RFP documents.
3. Pre-Proposal Conference will be held on **20<sup>th</sup> March, 2025 at 1200 hours** in the conference hall at the address mentioned below.

Bidding documents, containing method of procurement (**Single Stage – Two Envelopes**), detailed terms & conditions etc. will be available on the website mentioned from **March 17, 2025** for downloading free of cost.
