## **RE-INVITATION FOR BIDS (RIFB)**

### **PROCUREMENT FOR OPERATIONS, MANAGEMENT & MAINTENANCE (OM&M) OF NOWSHERA (N-45) TOLL PLAZAS (MANUAL) ON NATIONAL HIGHWAYS AND COLLECTION OF TOLL REVENUE ON NET GUARANTEED MONTHLY FIXED REVENUE TILL THE PERIOD ENDING 30<sup>TH</sup> JUNE, 2023**

1. National Highway Authority re-invites sealed bids on **Net Guaranteed Fixed Revenue Basis** (excluding all taxes, duties, charges/levies etc.) for subject services from bidders who can prove their qualification and eligibility as per requirement mentioned in Bidding Documents for subject services till the **period ending 30<sup>th</sup> June, 2023**:

- Bidding will be carried out by adopting **“Single Stage Two Envelope”** procedure.
- Tender will be awarded to Highest Evaluated bidder till the period ending 30.06.2023.
- Bidders are required to be registered with Pakistan Engineering Council (**PEC**) and having a valid PEC license in Operators **Category “O-5 or above” for FY 2021-22** as well as possess NTN and to be on ATL of FBR.
- Bid Security in the form, amount and for the validity period as mentioned in bidding Documents must be accompanied with **“Financial Bid”**.
- Declared defaulters/de-barred firms within NHA or any other Govt. Deptt. will not be eligible to participate in bidding process. However, the bidder(s) whose case are/is already sub-judice or dispute/arbitration is in process, shall not be treated as defaulter(s) and will be considered for bidding on case to case basis subject to the approval of NHA.
- Bidding Documents in respect of subject services is available and can be downloaded from NHA Website [www.nha.gov.pk](http://www.nha.gov.pk). This advertisement is also available on NHA and PPRA websites.
- All bidders are requested to submit written Confirmation (Power of Attorney) authorizing the person to submit the bid at the time of bid submission. Written confirmation from owner/head, authorizing the signatory of the Bid to sign the Bid must also be accompanied with the **“Technical Bid”**
- The prospective bidders shall provide following undertaking as a mandatory requirement on stamp paper of Rs. 100/- duly attested by Oath Commissioner stating that:
  - He/his firm is not blacklisted and he is not defaulter of any Government Departments.
  - They have gone through all Bidding documents/Request for Proposal (RFP).
  - The information/record given with the bidding documents are correct and they have not concealed any relevant information.

10. The prospective bidders are directed to provide the following documents along with **Technical Proposals**, failing to provide the required documents will be consider **Non Responsive**:

- a) Bidder's Application/Letter of Intension to participate in a particular toll plaza must be attached with the Technical Proposals.
- b) Technical & Financial Bids shall be signed & stamped by the authorized person.
- c) In case of Individual – Copy of CNIC along with Affidavit as owner of the company duly attested by Notary Public / Oath Commissioner.
- d) In case of Firm - Form – C issued by Registrar of Firm along with partnership deed / or partners name with distribution of shares.
- e) In case of Company - SECP certificate along with Memorandum of Association and Article of Association.
- f) In case of Authorized Representative - Affidavit must be issued from Owner/Directors of the Firm/Company and attested by Notary Public / Oath Commissioner, in respect of the person given authorization with his sample of signatures.
- g) All other required undertakings and affidavit must be attested by Oath Commissioner.

10. Sealed bids containing both Technical and Financial bids in separate envelopes shall be received in NHA Auditorium Islamabad on **15<sup>th</sup> August, 2022** until **1100 Hrs**. The Envelope containing Technical Bid will be opened on same day at **1130 Hrs** in the presence of the Bid Opening & Evaluation Committee and bidders/authorized representative (who wishes to attend). Financial Bids of only technically qualified bidders shall be opened on the date to be communicated later on.

11. The bidder shall provide an undertaking on Judicial Stamp paper duly notarized that the bidder is not defaulter of any Govt. Deptt. Including NHA, as well as not blacklisted anywhere from Pakistan.

12. The bidders providing unsubstantiated and / or incorrect information are liable to legal action and disqualification.

13. The Authority reserves the right to reject any/all bids at any time prior to the acceptance of a bid in accordance with PPRA's Rules 2004 (as amended in 2008).
