
General Terms & Conditions:-

- i. Earnest money as mentioned above must be attached with the tender documents in form of demand draft /pay order in the name of DDO/DFO Chilas from any schedule bank.
- ii. Tender with incomplete supporting documents shall not be accepted and furnished incorrect information shall be liable to legal action.
- iii. An affidavit on stamp paper of Rs. 100/- must be accompanied with the tender documents to the effect that the



bidder has never been blacklisted by any Government/Sami Government, organization /PPRA.

- iv. The firm/contractor winning the bid shall be bound to supply the item to this office till 30th June, 2024.
- v. The tender shall be considered item mentioned and firm shall be bound to supply /provide goods /service at rates quoted in tender during the financial year 2023-24.
- vi. Firms quoting inappropriate rates with respect to market rates to bring itself himself shall not be considered
- vii. Firm's contractor is required to to fill all boxes with appropriate market rates and / or box shall remain unfilled.
- viii. The contractor must have his own sho/workshop to participate in the tender firm /contractor must have at least ten (10) years experience for category at "A" with at least five (5) years bank statement must be attached and can only participate in tender ad attached with tender documents.
