4. The following mandatory documents must be submitted with bid online through EPADS:-
 - a. Copy of registration issued by relevant forum.
 - b. An affidavit that contractor/ firm/ vendor is not black listed in any Govt./ Semi Govt. Department or any other agency.
 - c. Valid registration with FBR.
 - d. One year bank statement duly signed & stamped by relevant Bank Manager.
5. **In the light of E-Pak, Procurement Regulations 2003, Bids shall be submitted through E-Pak Acquisition & Disposal System (EPAD) and bid prepared strictly in accordance with the instructions provided in the bidding document shall be received on or before (details as per schedule mentioned above), in the presence of the contractors/ firms/ vendors or their authorized representative who care to be present at that time.**
6. Bid should accompany a Pay Order or Bank Draft issued by any Scheduled Bank equivalent 3% to the amount mentioned against **each zone** in the name of "PASSCO", as Bid Security. No CDR will be accepted.
7. Tender documents which contains the detailed terms & conditions, method of procurement, procedure for submission of bids etc; can be obtained from the zonal offices/ Field Wing, PASSCO, Head Office Lahore on cash payment of **Rs.3,000/-** (non-refundable) on production of original requisite documents as per schedule mentioned above.
8. Tender documents (Bid) being tempered or over written will be rejected.
9. Any information related to Works, if required can be obtained from the respective Zonal Office during the working hrs.
10. PASSCO may reject "non-responsive" bids, as per PPRA Rules.
