

5. Tender must be comprise on two envelopes, one contain priced tender and other priced BQs duly seal.

6. If tender of a contractor not enlisted with MES is accepted he shall required to deposit Rs.25,000/- as security in the form as demanded be accepting officer. Tenders shall be issued to contractors upto **19 Apr 2024** during office hours.

7. Copies of the conditions of contracts, sch drawing and all other documents connected with the work can be examined / obtained from the office of undersigned.

8. Tender must be quoted on MES Schedule of Rates 2014. Tenders must reach before **19 Apr 2024 on 11:00 Hrs** and will be opend at 12:00 Hrs on same date.
