All interested Bidders are requested to submit following documents for Technical Pre-qualification **along with Original Pay order/Demand Draft** with **Technical Bid** of the subject works:-
- Submission of Request letter to participate in Technical Bid for Pre-qualification in the name of General Manager (NA's) NHA Abbottabad (**must be attached with Technical Bid**).
 - Valid Pakistan Engineering Council Certificate **C-5** or above with specialization **CE-01 & CE-10** for the **year 2021**.
 - Bid Security 2% of the Engineer Estimate in form of **Original Pay order/ Demand Draft in favor of General Manager (NAs) National Highway Authority Abbottabad (Instead of NHA)**.
 - Financial Competence documentation which must include.
 - **Readable/attested Auditor Reports of the firm for the **Last 3 Years** vetted by Chartered Accountant firm registered with **ICAP** Pakistan to assess the Financial Capacity of the Firm(s) in line auditing standards as per table-1 (Tender Document).
 - Bank statement (last 03 years duly verified by concerned bank).
 - *Experience of at **least Two (02) similar nature of works** completed during the **last Five (05) years having financial worth upto Rs. 24 million for Serial No. 01 and 18 million for Serial No. 02** must be completed. The completion certificate/Performance Certificate must be provided.
 - List of Professional Technical staff undertaking (**On Judicial Stamp Paper**) along with (CV's).
 - Contractor to provide the list of Equipment **on Judicial Stamp Paper**.
 - Pending Litigation/No Litigation Certificate **on Judicial Stamp Paper**.
 - The bidder must have to provide (**Bill of Quantities along with Financial Bid Documents**).
3. Interested eligible bidders may obtain further information on or before **May 24, 2021** from the office of Director (Maintenance) NHA, House No. 394 Street No. 03, Jinnahabad Abbottabad. **Tender Documents are also available on NHA Website for downloading.**
4. Sealed Technical and Financial Bids Documents complete in all respects in separate envelopes, along **with Pay order/ Demand Draft in favor of General Manager (NAs) National Highway Authority Abbottabad (Instead of NHA)** reach to this office on or before **May 25, 2021 at 1100 Hours** and shall be opened on the same day at **1130 Hours**, in the presence of Contractor/representative.
5. After conducting Technical Evaluation, Pre-qualified firms shall be informed accordingly for opening of their Financial Bids while bids of unqualified firms shall be returned unopened.
6. The Firms providing unsubstantiated/incorrect information are liable to legal action and disqualification.
7. Any deficiency, in the Tender Documents or incomplete information/BOQ shall be rejected. All pages of Tender Documents/Technical Bids must be page numbered signed and stamped by the respective Contractor/Authorized Representative, otherwise tender will be rejected.
8. The Contractor may provide the power of attorney as mention in the bidding documents (**on Judicial Paper for Rs. 100/- duly Countersigned from 1st Class Magistrates**).
9. NHA reserves the right to accept or reject any or all bids at any time prior to the acceptance of a bid or proposal (As per PPRa Rule 2004, clause 33).
