- Tender must be accompanied by Bank Guarantee for any amount not less than Rs 300,000/- to be valid for 180 days (one hundred & eighty) in the form Bank Guarantee / Call Deposit / Pay order issued by any Schedule Bank of Pakistan.
- Tender form can be obtained from the office of Chief Operation Officer PESCO against iv. non-refundable amount of Rs 10000/- (per lot) on any working day during office working hours till a day earlier from the opening of the tender.
- Tender will be received manually at the time mentioned above, However, a representative should be present at the time of opening.
- There will be no sale for tender documents on the date of opening of tender. vi.
