Online/ Electronic tenders are invited through web portal <https://etender.mlc.gov.pk> accompanied by earnest money in shape of deposit-at-call, in favour of Executive Officer, Walton Cantonment board from contractors/firms heaving valid PEC in category C-6 or above with specialization in codes CE-9, CE-10 & registered with FBR for the following works on MES Schedule of Rates 2021.

- 1) Interested bidders can only submit their bids online through e-Tender Portal of ML&C Dept (<https://etender.mlc.gov.pk>).
- 2) Contractors having valid NTN No, STRN No and PEC Registration of relevant codes are eligible to apply.
- 3) The cutoff time for submission of online bids will be 1400 hrs dated 16 / 06 / 2025 and shall be opened on same day at 1430 hrs electronically on the portal. The contractors will be able to see the comparative statement online.
- 4) If for any reason, office remains closed on the date of tender, it will be opened on next working day.
- 5) The bidders are required to submit bid security in shape of call deposit receipt (CDR) as mentioned above.
- 6) E-tenders without attachment of call deposit in favour of the undersigned equal to the earnest money will be rejected.

- 7) The successful contractor shall enter into a prescribed agreement (at their own cost on non-judicial stamp paper) with the CB Walton within 07 days of issuance of acceptance letter.
- 8) The issuance of work order shall be subject to approval from Board.
- 9) The validity of tender rates shall be upto 180 days as per PPRA / PEC Rules.
- 10) The contractor / bidders who quote their bids / rates more than 10% below on MES Schedule of rates 2021/Engr estimate shall submit performance guarantee equal to 10% of estimated cost under rule 39 of PPRA Rules 2004.
- 11) The Cantonment Board reserves the rights to demand the analysis of quoted rates to check their reasonability and workability.
- 12) The Cantonment Board/ Executive Officer reserve the right to reject the tender as per PPRA's Rule No.33 (I) due to any reason thereof.
- 13) The CDRs uploaded online shall be deposited in the office on the same day of opening of bids. In case of failure the bids submitted will be rejected.
